TRANSITIONAL ALLOWANCE

Article 13 of the Statute and Article 46 of the Implementing Measures

6 monthly payments equal to the salary referred to in Article 10 of the Statute (gross monthly amount: EUR 8 611.31¹)

NB: Where a recipient of this allowance carries out any of the activities listed in Article 46 of the Implementing Measures², the gross salary for the activity concerned will be offset against the gross amount of the transitional allowance guaranteed by Parliament.

¹ Each year there is an adjustment, backdated to 1 July of the reference year, to the salary referred to in Article 10 of the Statute. An EU withholding tax is levied on the gross amount in accordance with Regulation (EEC, Euratom, ECSC) No 260/68 of the Council of 29 February 1968 laying down the conditions and procedure for applying the tax for the benefit of the European Communities (OJ L 56, 4.3.1968, p. 8).

² I.e. membership of a parliament with legislative powers, a paid elected post involving the exercise of the prerogatives of public authority, membership of a national or regional government, a post as a senior official exercising public authority or a post as a member or official of an EU institution.

OLD-AGE PENSION

Article 14 of the Statute and Articles 47 and 49 of the Implementing Measures

On the basis of established pension entitlements on the reference date (29/03/2019), the gross monthly amount is equal to:

16.3333 %³ of the salary referred to in Article 10 of the Statute (= EUR 1,406.51⁴)

This pension is payable as from age 63 at the earliest, provided that no transitional allowance is received.

REIMBURSEMENT OF MEDICAL EXPENSES

Article 18 of the Statute and Article 3 of the Implementing Measures

Recipients of a transitional allowance or an old-age pension are entitled to reimbursement of two thirds of the costs incurred as a result of sickness, pregnancy or the birth of a child.

³ For each full year of service, the gross monthly amount of the pension is 3.5% of the salary referred to in Article 10 of the Statute, plus one twelfth of 3.5% for each further full month of service, after the date on which the Statute entered into force (14/07/2009).

⁴ That amount is calculated on the basis of the current salary of an MEP; it is subject to the EU withholding tax (see above).
